Business Breakthrough Group

- Philanthropic trusts, foundation and related activities
- Shareholders: **Mr Koh Siow Ngea**, **Mr Chew Eng Han** and **Mr Lam Leng Hung**
- Started in 2003 as an “outreach to the marketplace”, according to City Harvest Church’s (CHC) website.

CityCare

- Founder: **Mr Tan Ye Peng**, a pastor at City Harvest Church
- The social enterprise conducts training in schools and initiates overseas humanitarian projects, including a relief mission to Haiti.

City College Holdings Ltd

- Founded in 2002 under City Harvest Community Services Association, a voluntary welfare organisation.

Xtron Productions Pte Ltd

- Production house co-owned by **Mr Koh Siow Ngea** and **Mr Choong Kar Weng** – both attend CHC.
- Specialises in live productions, such as pop singer Ho Yeow Sun’s concerts in Singapore, Taiwan and China, as well as events including the opening of Skin Couture boutiques in its portfolio.
- Ho Yeow Sun’s US website lists it as one of her management companies.

Ministries

Affiliated churches

- 47 such churches in Singapore and overseas. CHC directly supervises 29 of them.

The School of Theology

- A full-time Bible college started in 1994 to train potential pastors and missionaries here and overseas.
- The course fees range from \$1,550 to \$1,800.
- Lecturers include senior church leaders such as **Pastor Kong Hee**, **Tan Ye Peng** and **Derek Dunn**.

The City Harvest Community Services Association

- Set up in 1996, it is the arm that does social work within Singapore.

The Marketplace

- This is a business networking ministry, formed to promote the development of SME businesses. It organises activities such as forums, seminars and business luncheons.

The Christian’s Men Network

- A support network set up to “instruct, inform and inspire” men and promote real manhood and character development.
